***Conditional Storage for Transshipment Containers - Max 168 hours:** La carga IMO en Transbordo (nave a nave), no debe exceder las 168 hrs de estadía en el terminal o 7 días.

***STI (San Antonio), solicita que las cargas IMO (que no sean Direct Delivery), ingresen a stacking el último día del stacking oficial. Esto puede variar de acuerdo a solicitud del terminal.**
